Question: What advice can you offer on funding an LLM programme?



### Ask the Expert



Dr Leyanda Purchase is the National Programme and Student Affairs Director for Academic Masters in Law Programmes at The University of Law.

Answer: At The University of Law, we understand that investing in your future can be a challenging financial commitment, but don't worry, there is a range of funding and payment options available to support you.

Student Finance England and Wales offer Postgraduate Master's Loans to assist towards the cost of a higher education courses. For courses starting on or after 1 August 2022, loans are available up to £11,836 and you can decide whether you want to use the loan towards your course fees, maintenance costs or other costs.

To be eligible for funding from Student Finance England, you must be studying an eligible course at a provider registered with the Office for Students (OfS) and whether you qualify will also depend on your age, nationality and residency status\*.

Alternatively, some high street banks offer graduate loans of between £1,000 and £15,000\*\* or Lendwise is another specialist UK education finance platform we recommend.

At The University of Law, we also offer instalment options and accept a number of payment methods, from cheque to direct debits, making the payment process more manageable. Full-time students can choose from a single instalment, three termly instalments or ten consecutive monthly instalments, and part-time students can choose from a single instalment, three termly instalments per year or twenty consecutive monthly instalments.

You could also be eligible for a full-fee or partial-fee scholarship from our £2million scholarship and bursaries fund.
